NOW, THEREFORE, I, Wendell R. Anderson, Governor of the State of Minnesota, acting pursuant to M. S. 490.101 and M. S. 490.102, do hereby order that the present term of office for the said Honorable Elmer R. Anderson be, and it hereby is, extended to and including July 5, 1974, and further order that retirement benefits commence as provided by law at the close of business on the day of July 5, 1974.

My Dear Governor:

In view of the fact that my term as Judge of the District Court of Minnesota will expire three years or less from the time when I will become eligible to retire under the provisions of Minnesota Statutes, Sections 490.101 and 490.102, I hereby inform you of my intention to retire upon eligibility.

My present age is 71 years, but my term of service as a judge of the district court, or as such judge and as judge of a court of record is less than 15 years. Therefore, I am not eligible to retire at the present time.

For your convenience I am quoting certain provisions of Minnesota Statutes which appear applicable to my situation, as follows:

M.S.A. Section 490.101, Subdivision 1. (a)
"When a judge of the district court who has served for not less than 15 years as such judge, or as such judge and as judge of a court of record, arrives at the age of 70 years and makes written application to the governor for retirement, the governor shall direct his retirement by a written order."

M.S.A. Section 490.102, Subdivision 2. (a)
"If, at the time of retirement, he has attained the age of at least 70 years and he has served for 15 years as such judge, or as such judge and as judge of a court of record, he shall receive for the remainder of his life, one-half the compensation allotted to the office at the time of his retirement or on July 1, 1967, whichever is greater."

Hon. Wendell R. Anderson:

M.S.A. Section 490.101, Subdivision 4.
 "When the term of any judge of the district court would expire three years or less from the time when he would become eligible to retire under the provisions of this section and Section 490.102, upon written application by such judge to the governor stating his intention to retire upon eligibility, the governor shall forthwith make a written order accepting such retirement application, and extending his term of office for three years or such proportion thereof as may be necessary to make him eligible for such retirement."

At a general election held in the City of Minneapolis on June 9, 1959, I was duly elected to the office of Judge of Municipal Court of said City, a court of record, for a term of six years, beginning on the first Monday in July, 1959, which day was July 6, 1959. On January 1, 1965, the Municipal Court of Minneapolis was expanded into the Hennepin County Municipal Court, a court of record, and the term for which I had been elected was extended to the first Monday in January, 1967.

At a general election held in the County of Hennepin on November 8, 1966, I was duly elected to the office of Judge of District Court of Minnesota, Fourth Judicial District, for a term of six years, beginning on the first Monday in January, 1967. This term expires on December 31, 1972, and I have the right to file for re-election.

According to my calculation, I will have served as a judge of courts of record continuously and without interruption for a period of 15 years at the close of the day on July 5, 1974.

My birthday is October 11, 1900, and my present age is 71 years.

In accordance with the provision of M.S.A. Section 490.101, Subdivision 4, I hereby apply for retirement and respectfully request that you make a written order accepting my retirement application, and extending my term of office to and including the 5th day of July, 1974.
