ORDINANCE NO. 481

AN ORDINANCE AMENDING ORDINANCE NO. 473, BEING AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE THEREIN CERTAIN TRACTS OR PARCELS OF LAND WHICH ARE BORDERED AT LEAST 60% BY THE MUNICIPALITY.

The Common Council of the City of Marshall do ordain as follows:

Section 1. Section 2 of Ordinance No. 473 is hereby amended by changing the period ending the concluding sentence of said Section 2 to a comma, and adding thereto the following, to-wit:

Said tract or parcel of land described above is also described as and includes:

All that part of the Southeast Quarter of Section 5, Township 111 North, Range 41 West, not already within said corporate limits; all that part of the West Half of Section 5, Township 111 North, Range 41 West, lying easterly of the east right-of-way line of the Redwood River Diversion Channel; all that part of the Northeast Quarter of Section 8, Township 111 North, Range 41 West, not already within said corporate limits; all that part of the Northwest Quarter of Section 8, Township 111 North, Range 41 West, lying easterly of the east right-of-way of the Redwood River Diversion Channel not already within said corporate limits; and also that parcel of land described as follows, to-wit: Beginning at the center of Section 8, Township 111 North, Range 41 West; thence west on the east and west quarter line approximately 1100 feet to the center of the Redwood River; thence downstream on the center of the Redwood River to the northerly extension of the east line of Westwood Acres Addition; thence south on said easterly line and said line extension to the southeast right-of-way line of Trunk Highway No. 23; thence north-easterly on said right-of-way line to the intersection of the east and west quarter line of said Section 8, Township 111 North, Range 41 West; thence west on said quarter line to the point of beginning.

Section 2. Except as amended herein, said Ordinance No. 473 shall remain in full force and effect.

Section 3. This Ordinance shall take effect from and after its adoption and publication, and from and after a certified copy thereof has been filed with the Minnesota Municipal Commission, the Town Clerk of Lake Marshall Township, the County Auditor of Lyon County and the Secretary of State.
