ORDINANCE NO. 91
AN ORDINANCE ANNEXING CERTAIN LANDS
TO THE VILLAGE OF STEWARTVILLE

WHEREAS, the lands described below is within the incorporated limits of the Village of Stewartville.

AND WHEREAS, the land and improvements thereon is urban in character.

AND WHEREAS, the annexation was petitioned by 100% of the land owners, no Public Hearing is required.

AND WHEREAS, the Village Council has determined that the annexation will be to the best interest of the Village of Stewartville.

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA, DOES ORDAIN:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville, to-wit:

A parcel of land commencing at the Northeast corner of said quarter section, marked by a stone monument: thence west along the north line of said quarter section a distance of 500.37 feet to the northwest corner of Brin's Second Addition, for a point of beginning thence south at right angles along the west line of Brin's Second Addition, 389.00 feet; thence west at right angles, 314.75 feet; thence north at right angles, 389.00 feet; thence east at right angles 314.75 feet to the place of beginning.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, County Auditor and Secretary of State.
