ORDINANCE NO. 378

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do
hereby ordain as follows:

Section 1.

WHEREAS the following described property situated in
the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Government Lot 3, Sec-
tion 3, T.153N., R.43W. bounded as follows:

Beginning at the Northwest corner of said
Government Lot 3; thence South along the West line
of said Government Lot 3 a distance of 130';
thence East along a line parallel to the North line
of Government Lot 3 to the centerline of the present
graveled road (Kendall Ave. extended); thence North
along a line parallel to said West line of Govern-
ment Lot 3 a distance of 100'; thence East along
a line parallel to the North line of said Govern-
ment Lot 3 a distance of 169'; thence North a
distance of 30' to the North line of said Government
Lot 3; thence West along said North line to the
point of beginning,

is completely surrounded by land within the municipal limits.

NOW, THEREFORE, pursuant to M.S.A. 414.033, Subd. 4 the
above described property is hereby declared to be incorporated
within and annexed to the City of Thief River Falls, Minnesota.

Section 2.

This ordinance shall be in force and effect from and
after its passage, approval, publication and filing with the
Municipal Commission, the Pennington County Auditor and the
Secretary of State of the State of Minnesota.
