ORDINANCE NO. 417

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY LOCATED IN THE TOWNSHIP OF ACOMA

THE CITY OF HUTCHINSON DOES ORDAIN:

SECTION I. A petition has been filed with the governing body of the City of Hutchinson by William Helland and the City of Hutchinson, being 100% owners of the following described real property, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to wit:

CITY OF HUTCHINSON: A tract of land in the Northwest Quarter of Section 36, Township 117 North, Range 30 West Mcleod County, Minnesota described as follows:

Communcing at the Northeast corner of said Northwest 2 of Section 36; thence North $59^{\circ}-55^{\circ}-00^{\circ}$ West along the North line of said Northwest k_{ρ} a distance of 565,92 feet to the centerline of County Highway No. 12; thence South 8°-37'-00" East along said centerline, a distance of 338.96 feet; thence along a tangent center-line curve, radius 2181.89 feet, central angle 19° 23', an are distance of 738.14 feet to the point of beginning; thence on a bearing of South 62°-00'-00" West, a distance of 208.7 feet; thence on a bearing of North 28°-00'-00" West, a distance of 208.7 feet; thence on a bearing of North 62°-00'-00" East to a point on said centerline of County Highway No. 12; thence Southerly along said tangent centerline curve to the point of beginning. Containing 1.0 Acre more or less, owned by City of Hutchinson.

WILLIAM HELLAND:

A tract of land in the Northwest Quarter of Section 36, Township 117 North, Range 30 West McLeod County, Minnesota, described as follows:

Commencing at the Northeast corner of said Northwest & of Section 36; thence North $89^{\circ}-55'-00"$ West along the North line of said Northwest ξ_{0} a distance of 565.92 feet to the centerline of County Highway No. 12; thence South 8°-37'-00" East along said centerline, a distance of 338.96 feet; thence along a tangent centerline curve, radius 2181.89 feet, central angle 19°-23', an arc distance of 738.14 feet to the point of beginning; thence on a bearing of South 62°-00'-00" West, a distance of 593.12 feet to a point in the South line of the North Half of said Northwest 4 of Section 36; thence South 90"-00"-00" East along said South line to a point on the centerline of said County Highway No. 12; thence North 28°-00'-00" West along said centerline, a distance of 315.37 feet to the point of beginning. Containing 2.15 acres more or less. Owned by, William Helland.

SECTION II. The quantity of land embraced within the foregoing description and bounded as described, is 3.15 acres, more or less.

SECTION III. The City Council hereby determines that the annexation will be to the best interests of the City of Hutchinson and the territory affected, and that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.
