## ORDINANCE NO. 351

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DETROIT LAKES, MINNESOTA TO INCLUDE GERTAIN LANDS

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by the owners of the following described real estate to have such land included within the City of Detroit Lakes, Minnesota:

A 7.74 acre tract of land which includes Karsner First Adition, Karsner Second Addition, Karsner Subdivision, and an unplatted area described as follows:

Commencing at the northeast corner of the northeast one-quarter of Section 4, Township 138 North, Range 41 West; thence west along the morth line of said Section 4 for a distance of 389.4 feet; thence south 01 degrees 07 minutes east along the east line of Karsner First Addition, Block Two, Karsner Subdivision and Karsner First Addition for a distance of 1013.8 feet, more or less, to Ecomens Subdivision; thence south 76 degrees 58 minutes west along the northwesterly edge of Bommans Subdivision for a distance of 50 feet; thence north 87 degrees 58 minutes west along the northwesterly edge of Bommans Subdivision and the southerly edge of Block 1, Karsner Subdivision, for a distance of 281.35 feet, more or less, to the southwest corner of Block 1, Karsner Subdivision; thence north 01 degrees 07 minutes west for a distance of 1019.6 feet to the north line of said Section 4; thence south 89 degrees 14 minutes east along the north line of said Section 4 (also the center line of existing Township Road) for a distance of 330 feet to the point of beginning of this description.

Section 2. The City Council hereby determines: (1) that the anneration till be in the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as property to be subjected to the city government.

Section 3. Therefore, the Council of the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same hereby is annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, the Clerk of the Town Board, and the Secretary of State, and from and after its passage and publication.
