ORDINANCE NO. 372

JAN 24 1972

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE
CITY OF THIEF RIVER FALLS

The City Council of the City of Thief River Falls do
hereby ordain as follows:

Section 1.

WHEREAS, all of the owners of the following described
premises situated in the County of Pennington and State of
Minnesota, to-wit:

The North Thirty-three Feet (N33') of the un-
platted portion of Government Lot Three (3);
North Thirty-three Feet (N33') of Government
Lots One (1) and Two (2) of Section Three (3),
Township One Hundred Fifty-three (153) North,
Range Forty-three (43) West and the North
Thirty-three Feet (N33') of Government Lot
One (1), Section Two (2), Township One Hundred
Fifty-three (153) North, Range Forty-three (43)
West, lying West of the centerline of Trunk
Highway No. 59, containing 3.1 acres more or
less,

have petitioned the City Council to have such land included
within the municipality and have filed copies of said Petition
with the Municipal Commission of the State of Minnesota, with
the Town Board of the Township of Rocksbury and with the
County Board of the County of Pennington, State of Minnesota,
and

WHEREAS, the above described property abuts upon the
boundaries of the City of Thief River Falls and,

WHEREAS, no objections to the proposed annexation have

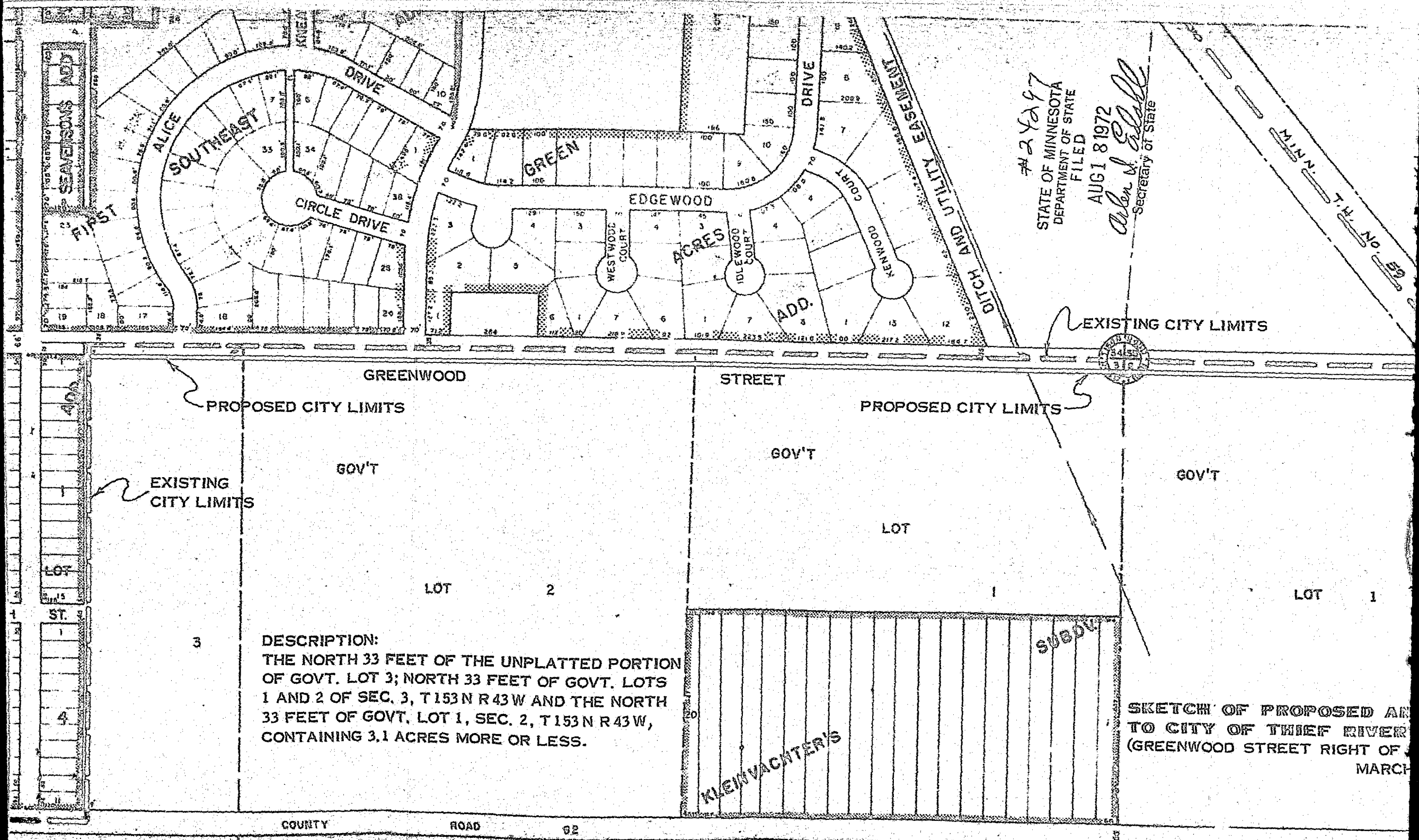
