ORDINANCE NO. 162

AN ORDIANCE ANNEXING A PART OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER (NE1/4 NW1/4), SECTION SIX (6), TOWNSHIP ONE HUNDRED TWENTY-FIVE (125), RANGE THIRTY-SEVEN (37), COUNTY OF POPE, STATE OF MINNESOTA TO THE CITY OF GLENWOOD, MINNESOTA.

THE CITY OF GLENWOOD DOES ORDAIN:

SECTION 1. There is hereby annexed to the City of Glenwood, Minnesota the following described premises;

All that part of the Northeast Quarter of the Northwest Quarter (NE1/4 NW1/4), Section Six (6), Township One Hundred Twenty-five (125), Range Thirty-seven (37), which lies a distance of 50 feet on each side of the following described lines:

Beginning at a point on the North line of the said Northeast Quarter of the Northwest Quarter (Nel/4 NWl/4) of Section Six (6), a distance of 400 feet West of the Northeast corner of the Northwest Quarter (NEl/4 NWl/4) of Section Six (6);

Thence South 11° 11' West a distance of 437.75 feet,
Thence deflect to the left in a Southeasterly direction along
the circumference of a circle whose radius is 1719 feet to a point in
the South line of said Northeast Quarter of the Northwest Quarter
(NE1/4 NW1/4) of Section Six (6) 433.25 feet distant West of the
Southeast corner of said Northeast Quarter of the Northwest Quarter
(NE1/4 NW1/4).

The foregoing tract of land is the tract of land presently occupied as the right-of-way of the main Winnipeg Line as the same crosses from the South to the North of the said Northeast Quarter of the Northwest Quarter (NE1/4 NW1/4).
