ORDINANCE NO. 461

An Ordinance Amexing Un-platted Lands to the City of Remidji Pursuant to Minne-sota Statutes 1965, Section 414.03, Subdivision 2,

soin Statutes 1065.

414.03, Subdivision 2.

Whereas, A petition has been filled with the City Clerk on May 8, 1968, signed by all the owners of the lands described therein praying that said land be annexed to the City of Bemidji,

And, Whereas, Proof has been presented to the City of Bemidji City Council establishing that said petition was served on the Town Board for Northern Township and the Board of Commissioners for Beltrami County wherein such lands described are located, and on the Municipal Commission of the State of Minnesots, said service on all of said governmental units and agencies having been made prior to May 15, 1969, have elapsed and no written objections to said annexation having been made to the City of Bemidji or to the Municipal Commission, NOW, THEREFORE, THE CITY OF BEMIDJI DOES ORDAIN:

1. That the City Council of Bemidji, Minnesota, does hereby determine that annexation into the City of Bemidji of the land described as follows:

That part of Government Lot Four (2), Section thirty

into the City of Bemidji of the land described as follows:
That part of Government Lot Four (4), Section thirty-three (33), Township on e hundred forty - seven (147) north, Range thirty - three (33) west, which tract is more particularly described as follows, to-wit:
Starting at the southwest corner of said Government Lot four (4), thence running east along the south boundary of said Lot 4 a distance of 450.5 feet to a point hereinafter designated as Point A, which point is the point of beginning of the tract of land to be annexed; Thence deflect to the left at the angle of 74° 58' and proceeding northeasterly a distance of 207.2 feet to a point called Point B, and yet the distance when measured at right angles to the south boundary line of said Lot 4, then the distance is sonly 200 feet from Point A to Point B:
Thence deflect to the right at an angle of 5° 16' and proceeding northeasterly a distance of 310.8 feet to a noint called Point C, and yet the distance when measured at right angles to the south

boundary line of said Lot 4, then the distance is only 300 feet from Point B to Point C; Thence deficet to the right at an angle of 4° 12° and continue in a northeasterly direction for a distance of 169.75 feet to a point called Point B, and yet the distance when measured at right angles to the south boundary line of said Lot 4, then the distance is only 100 feet from Point C to Point D; Thence deflect to the right and running cast along a line parallel with the south boundary line of said Lot 4 to a point at the center line of Birchmont Drive, formerly established as State Rural Highway 9B, which point is called Point E; Thence deflect to the right and running along the center line of Birchmont Drive a distance of 600 feet to the point of intersection with the south boundary line of said Lot 4, which point is called Point F; Thence deflect to the right and running west along the south boundary of said Lot 4 a distance of 578.28 feet, more or less, to Point A, which Point A has been previously designated as point of beginning; will be to the best interests of the City of Bemidil and of the format herein are hereby angles.

2. That the said lands described herein are hereby annexed by and into the City of Bemidji and that the propercity and other government officers are hereby authorized and directed henceforth to amend, revise or remake all plats showing the geographical confines of the City of Bemidji to include as a part thereof the lands hereby annexed.

3. This ordinance shall take effect and be enforced from and after twenty days from the date of its passage.
