- (3) East part of the NWW of the SEW, Section 8, Township 108, Range 26, Blue Earth County, Minnesota. Said land is running from North to South 80 rods and East to West 24 rods containing 12 acres.

The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor. This Ordinance shall take effect ten days after the date of its passage and publication.
