KNOW ALL MEN BY THESE PRESENTS, That I, WARREN SPANNAUS,
Attorney General of the State of Minnesota, by virtue of the
authority vested in me by statute, and upon the written request
of the Department of Aeronautics, do hereby constitute and appoint

C. BLAINE HARSTAD

of Minneapolis, Minnesota, as a Special Attorney for the purpose
of providing legal services to the Department of Aeronautics and
such other matters as the Attorney General may assign, and to serve
at the pleasure of the Attorney General or until this appointment
shall be revoked or otherwise terminated in accordance with law.
This appointment shall be effective November 17, 1971, and is
subject to the terms and conditions hereinafter set forth:


1. REPORTS. The Special Attorney shall submit a monthly
report setting forth in detail his activities regarding this
appointment for the previous month.

2. COMPENSATION AND EXPENSES. As compensation for satisfactory
performance of the duties herein described, the Special Attorney
shall receive Thirty Five Dollars (\$35.00) per hour. Said compen-
sation shall constitute payment in full for all services rendered
by the Special Attorney. The Special Attorney shall be reimbursed
for travel and other expenses (other than ordinary office expenses)
in accordance with the rules and regulations promulgated by the
State of Minnesota, Commissioner of Administration governing the
travel of state officers and employees. All compensation and

expenses shall be paid from funds appropriated to the Department of Aeronautics.


3. STATUS. The Special Attorney shall not be eligible for the state's life insurance or basic health benefits coverage and shall not accrue vacation or sick leave or any benefits other than those expressly provided herein.




