2. COMPENSATION AND EXPENSES. As compensation for satisfactory performance of the duties herein described, the Special Attorneys shall be compensated at a rate of \$30.00 per hour. The Special Attorneys shall be reimbursed for travel expenses in accordance with the rules and regulations promulgated by the State of Minnesota, Commissioner of Administration governing the travel of state officers and employees. All compensation and expense shall be paid from funds appropriated to the Board of Barber Examiners.

3. STATUS. The Special Attorneys shall not be considered state employees, shall not be eligible for the state's life insurance
