ORDINANCE NO. 1

AN ORDINANCE PROVIDING PARKING AND TRAFFIC REGULATIONS FOR WORTHINGTON STATE JUNIOR COLLEGE AND IMPOSING A PENALTY FOR THE VIOLATIONS THEREOF.

Be it ordained by the State Junior College Board.

Section I - Parking and traffic rules and regulations adopted.

The Minnesota State Junior College Board, pursuant to Minnesota Statute 169.66 and Minnesota Session Laws Chapter 966 Section 20 (1971), hereby adopts the following Parking Traffic Rules and Regulations to be administered and enforced on the property of Worthington State Junior College.

1. Only those vehicles belonging to students or employees of Worthington State Junior College or to other persons having a purpose or function at the college may park on college property.
2. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs or in areas by other than those specifically designated for the classified and unclassified college personnel. Exceptions to this regulation are as follows:
  - a. College-owned vehicles, when being used in the performance of work on college property.
  - b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
3. Parking in a restricted area shall be limited to those persons who have been issued a Special Permit for parking in a restricted area. Special Permits are issued by the Dean of Students in the form of a card or sticker which must be displayed when the vehicle is parked in the restricted area.
4. Parking lanes are designated by painted yellow lines. Adequate space has been provided between each set of yellow lines to park an automobile. Parking is restricted to a maximum of one parking lane per vehicle. Parking on yellow lane lines or parking in a position which occupies more than one parking lane or blocks the exit or entrance of another vehicle is prohibited.

5. All vehicles are required to follow directional arrows, signs, and regular roadways to gain entrance to and exit from parking areas.
6. Maximum speed of vehicles on college property shall be 20 miles per hour, and such lesser speeds as may be indicated by posted signs.
7. The dumping or depositing of any refuse on college property is prohibited.
8. The regulatory provisions of Minnesota Statutes 1961 Chapter 169, as amended, are hereby adopted as traffic ordinance regulating the use of parking facilities and private roads, roadways and college property owned, leased, occupied or operated by the Worthington State Junior College.
9. No person shall drive or operate a snowmobile or any other vehicle other than as specified in this ordinance on property owned, leased, occupied, or operated by the Worthington State Junior College without the express written permission of the President of the college or his designate.

Section II - Enforcement

Every sheriff, constable, police officer, or other peace officer shall see that all rules and regulations of this ordinance are obeyed and shall arrest and prosecute offenders.

Section III - Penalties

Any person violating any provision of this ordinance shall be guilty of a misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the City of Worthington in the same manner as fines received from the violation of City of Worthington Ordinances.

Section IV - Effective Date

This ordinance shall be in full force and effect from and after its adoption according to law.

# Affidavit of Publication

Vance, being duly sworn, on oath says he is and during all the times herein stated has been president of the Worthington Daily Globe, Inc., the publisher and printer of the newspaper known as Worthington Daily Globe and has full knowledge of the facts herein stated as follows: (1) Said newspaper is printed in the English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. (6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the managing officer of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.
