ORDINANCE ANNEXING CERTAIN LANDS
TO THE VILLAGE OF STEWARTVILLE

WHEREAS, the lands described below is within the incorporated limits of the Village of Stewartville.

AND WHEREAS, the land and improvements thereon is urban in character, is and has been receiving the benefits of Village services.

AND WHEREAS, the land is completely surrounded by Village lands, no Public Hearing is required.

AND WHEREAS, the Village Council has determined that the annexation will be to the best interest of the Village of Stewartville and territory affected:

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA, DOES ORDAIN:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville, to-wit:

A parcel of land in the Northeast quarter (NE¹/₄), Southeast quarter (SE¹/₄) of Section Twenty-seven, Township One hundred Five, Range Fourteen, commencing at the NW corner of said SE¹/₄, thence easterly a distance of 1467.5 feet to the point of beginning, thence easterly a distance of 209.5 feet, thence southerly a distance of 311.9 feet, thence westerly a distance of 209.5 feet, thence northerly a distance of 311.9 feet to the point of beginning.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, County Auditor and Secretary of State.
