

ORDINANCE NO. 224

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF REDNOOD FALLS

THE CITY OF REDNOOD FALLS DOES ORDAIN:

1. That it is hereby found and determined:

A. That the lands hereinafter described are entirely

surrounded by lands within the corporate limits of the City of Redwood Fells.

B. That said lands are urban in character.

C. That said lands are suitably conditioned for

municipal government.

D. That it is for the best interests of the City of Redwood Falls and the owners and residents of said lands that the same be annexed to the City of Redwood Falls.

2. That the following described lands lying and being in the County of Redwood, State of Minnesota, are hereby annexed to the City of Redwood Falls, to-wit:

All that part of the Northeast Fractional Quarter (NEFr¹₂) of Section Six (6), Township One Hundred Twelve (112) North, Range Thirty-five (35) West, described as follows:

Commencing at the northwest corner of the said Northeast Fractional Quarter (NEFr¹₂) of said Section Six (6) and running thence east on the north line of said Section Six (6) a distance of 500 feet, thence south parallel with the west line of said Northeast Fractional Quarter (NEFr¹₂) of said Section Six (6) a distance of 703.4 feet, thence west parallel with the north line of said Section Six (6) a distance of 500 feet, and thence north along the west line of said Northeast Fractional Quarter (NEFr¹₂) of said Section Six (6) a distance of 703.4 feet to the place of beginning.

3. That this ordinance shall be in full force and effect from and after its passage and publication.
