ORDINANCE NO. 22

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF GHENT TO INCLUDE CERTAIN
UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES

The Common Council of the Village of Ghent do ordain as follows:

Section 1. A petition has been filed with Common Council of the Village of Ghent, Minnesota, by the sole owners of the following described real estate in the County of Lyon, State of Minnesota, to have the following described land included within the Village of Ghent, Minnesota:

All that part of the Southwest Quarter (SW $\frac{1}{4}$) of Section Ten (10), Township One Hundred Twelve North (112N), Range Forty-two West (42W) of the Fifth Principal Meridian in Lyon County, Minnesota, described as follows:

Commencing at the Southwest corner of Section Ten (10), Township one hundred twelve North (112N), Range Forty-two West (42W); thence Easterly along the South line of said Section Ten (10) a distance of Eight hundred twenty-nine (829) feet to the true point of beginning; thence Northerly at right angles three hundred thirty-three (333) feet; thence Easterly and parallel with the South line of said Section ten (10) a distance of one hundred sixty (160) feet; thence Southerly at right angles three hundred thirty-three feet to a point on the South line of said Section Ten (10); thence Westerly along the South line of said Section Ten (10) a distance of one hundred sixty (160) feet to the true point of beginning.


Section 2. The quantity of land embraced within the foregoing description, and bounded and described, is 1.2 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the Village of Ghent, Minnesota, and of the territory affected; and (2) that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to village government.

Section 4. Therefore, the Village of Ghent, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the Village of Ghent, Minnesota, as effectually as if it had originally been a part hereof.



This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Grandview Township, the County Auditor of Lyon County and the Secretary of State, and from and after its passage and publication.
