ORDINANCE NO. 84 ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF BAGLEY

BE IT ORDAINED BY THE VIL-
LAGE OF BAGLEY AS FOLLOWS:

That the real estate hereinafter

eran Church of Bagley, Minnesota,
and abutting upon the incorporated
portion of the Village of Bagley,
said tract or parcel of land located
in the County of Clearwater and
State of Minnesota, to-wit:

Lots One (1), Two (2) and Three
(3), Block One (1), Neujahr's Lake
View, according to the plat there-
of on file and of record in the of-
fice of the Register of Deeds in
and for said county,

All that part of Lot Fifteen (15),
Block One (1), Neujahr's Lake
View, described as follows: Com-
mencing at the Southeast Corner
