AN ORDINANCE TO ANNEX CERTAIN LAND TO THE VILLAGE OF AMBOY, MN

The Village of Amboy, Minnesota, does ordain:

That certain real estate be annexed to and incorporated in the village limits of Amboy, said real estate being described as follows:

> Beginning at the Northwest corner of Truwe's Second Addition to Amboy according to the plat on file and of record with the Register of Deeds, Blue Earth County, Minnesota; thence South 0 degrees - 17 minutes - 48 seconds East (assumed bearing) along the West line of said Truwe's Second Addition to Amboy and the southerly extension thereof, 417.22 feet; thence South 90 degrees - 00 minutes - 00 seconds West, 4.55 feet to a point of curvature of a circular curve to the right; thence along a 480.29 foot radius curve, central angle 16 degrees - 00 minutes - 00 seconds, an arc distance of 134.12 feet to the point of tangency of said curve; thence North 74 degrees -00 minutes - 00 seconds West along the tangent 8.87 feet to the point of curvature of a circular curve to the left; thence along a 417.46 foot radius curve, central angle 16 degrees - 00 minutes - 00 seconds, an arc distance of 116.58 feet to the point of tangency of said curve; thence South 90 degrees -00 minutes - 00 seconds West along the tangent, 182.59 feet; thence North O degrees - 17 minutes -48 seconds West and parallel with the West line of Truwe's Second Addition to Amboy, 380.00 feet to a point on the southerly right-of-way line of Minnesota Trunk Highway No. 30; thence North 90 degrees - 00 minutes - 00 seconds East, along said southerly right-of-way line, 442.90 feet to the point of beginning.

This annexing ordinance shall become final upon proper filing pursuant to Minnesota Statutes 414.033, Subdivision 7.
