AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO INCLUDE CERTAIN UNINCORPORATED PLATTED TERRITORY NOT EXCEEDING 200 ACRES, 60% OR MORE OF WHICH IS BORDERED BY PROPERTY WITHIN THE CITY

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory, 60% or more of which is bordered by lands already included within the corporate limits of the City, does not exceed 200 acres; and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed;


THE CITY OF MANKATO, MINNESOTA, DOES ORDAIN:

1. That the annexation will be to the best interests of the City and of the land affected;
2. That the land described herein abuts upon the City Limits and is urban in character; and
3. That none of said land is now included within the limits of any city, village, or borough.


The corporate limits of the City are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been part thereof:

Lots 9, 10, 11, and 12, Vernon O. and Willow L. Tufte's Subdivision of South 12.84 acres of the Southeast 1/4 of the Northeast 1/4 and the South 1/2 of the West 6.59 acres of the South 13.17 acres of the North 26.34 acres of the Southeast 1/4 of the Northeast 1/4 of Section 19, Township 108N, Range 26W.

The City Clerk is hereby directed to file certified copies of the Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor. This Ordinance shall take effect ten days after the date of its passage and publication.


