

AN ORDINANCE PERTAINING TO ANNEXING PROPERTIES OWNED BY GALE PLANTE TO THE VILLAGE OF FORT RIPLEY, MINNESOTA IN ACCORDANCE WITH THE PROCEDURES ESTABLISHED AND AUTHORITY GRANTED BY STATE LAW

WHEREAS, Gale Plante has appeared before the Fort Ripley Village Council in his own behalf and has presented a petition requesting annexation to the Village of Fort Ripley, Minnesota, and

WHEREAS, Gale Plante has complied with the provisions of Subdivision 5, Section 414.044 of Chapter 414 of Minnesota State Statutes,

NOW, THEREFORE, The Village Council of Fort Ripley, Minnesota ordains that the following regulation be adopted:

ARTICLE I - GENERAL PROVISIONS

Section 1.1 - Short Title: This Ordinance shall be known as Ordinance Number 1-72, Plante Annexation Ordinance.

Section 1.2 - Purpose: The purpose of this Ordinance is to complete annexation proceedings in accordance with Subdivision 5, Section 414.044, of Chapter 414 of Minnesota State Statutes.

Section 1.3 - Scope: This Ordinance shall apply to those lands described as SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 35, Range 32 of Crow Wing County.

ARTICLE II - PROCEDURAL REQUIREMENTS

Section 2.1 - Costs: Gale Plante as petitioner, shall bear all costs pertaining to this annexation.

Section 2.2 - Administrative Action by Village Council: The Village Clerk of the Village of Fort Ripley, will upon

effective date of this Ordinance cause notification to be given all agencies concerned by submitting a copy of this Ordinance to them.

Section 2.3 - Administrative Action by Petitioner: It shall be the responsibility of the petitioner after action is completed to insure that appropriate notification is given to all offices of record pertaining to lands.

ARTICLE III - EFFECTIVE DATE

Section 3.1 - Effective Date: This Ordinance shall become effective on the date it is posted to the Village Ordinance Book.
