

ORDINANCE NO. 570

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation of the State of Minnesota, to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, A Petition has been filed with the governing body of the City of Willmar, a Municipal Corporation in the State of Minnesota by the sole owner having any interest therein, to have certain real property, hereinafter described, included within the limits of the City of Willmar, Minnesota, and

WHEREAS, It is proposed to annex by virtue hereof to the said City of Willmar, said property, all of which said property is in Kandiyohi County in the State of Minnesota, and

WHEREAS, The said property to be annexed consists of approximately 47 acres described as follows:

All that part of the Northwest 1/4 of Section 21, Township 119 North, Range 35 West, of the fifth principal meridian, lying Northwesterly of the right-of-way of the Great Northern Railway over and across said Northwest 1/4, except a tract described as follows: commencing at the Northwest corner of said Section 21, thence South along the Westerly line of said Section a distance of 208 feet; thence East on a line parallel with the North line of said Section a distance of 208 feet; thence North on a line parallel with the West line of said Section a distance of 208 feet; thence West along the North line of said Section 208 feet to the point of beginning, all in Kandiyohi County, Minnesota.

NOW THEREFORE, the City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best interest of City of Willmar and area to be annexed. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the territory affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits, and is so conditioned as property to be subject to City government.

Section 3. Annexation. That the said property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had originally been a part hereof.

Section 4. Zoning. The area above described shall be zoned I-2, Industrial District.

Section 5. Effective Date. This ordinance shall be filed and shall take effect and be at full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota, and the Secretary of the State of Minnesota, and from and after its passage and publication.
