ORDINANCE NO. 121

AN ORDINANCE ANNEXING TO THE VILLAGE OF LA CRESCENT IN HOUSTON COUNTY, MINNESOTA, TERRITORY OWNED BY THE VILLAGE OF LA CRESCENT AND ABUTTING ON SAID VILLAGE PURSUANT TO THE PROVISIONS OF SECTION 414.033, MINNESOTA GENERAL STATUTES, AS AMENDED

The Village Council of the Village of La Crescent, Houston County, Minnesota, ordains as follows:

1. The Village of La Crescent, Minnesota is the sole owner of real estate hereinafter described.
2. The said real estate abuts on said Village, is not included in any other municipal, is unplatted and does not exceed 200 acres in area.
3. The annexation of the said real estate to the Village of La Crescent which real estate is urban in character, will be to the best interests of said Village, of said real estate and of the territory affected thereby.
4. Pursuant to the provisions of Section 414.033, Minnesota General Statutes as amended, it is hereby declared that the real estate hereinafter described is hereby annexed to, included with and made a part of the Village of La Crescent in Houston County, Minnesota, said real estate being situate in said County of Houston and described as follows, to-wit:

The north 18 feet of the following described tract: Commencing at the northwest corner of the northeast quarter of the northwest quarter of Section 15, Township 104 North, of Range 4 West of the Fifth Principal Meridian, thence south 0° 25' east on the west line of the said northeast quarter of the northwest quarter 135 feet; thence south 89° 11' east 132 feet, thence north 0° 25' west 135 feet to the north line of said northeast quarter of the northwest quarter, thence north 89° 11' west 132 feet to the place of beginning.

5. This ordinance shall become effective upon its passage and adoption and the publication as provided by law and its filing as provided by Chapter 414, Minnesota General Statutes, as amended.

Passed and adopted by the Village Council of the Village of La Crescent, Minnesota, this 1st day of May, 1972.
