ORDINANCE NUMBER 132 VILLAGE OF FOLEY BENTON COUNTY, MINNESOTA

AN ORDINANCE AMENDING CERTAIN ANNEXATIONS DESCRIBED IN ORDINANCE NUMBER 130

THE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, ORDAINS AS FOLLOWS:

That the Code of Ordinances as amended by Ordinance Number 130 dated April 18, 1972, be amended by deleting therefrom Section 100:09 (3) (a) and (b).

FURTHER, THE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, CROATHS AS FOLLOWS:

That the Code of Ordinances as smended by Ordinance Number 130 dated April 18, 1972, be amended by substituting the following subdivisions for the original subdivisions set forth in Sections 100:09 (3) (g) and (h), to read as follows, to-wit:

Section 100:09 (3) (g). A strip of land in the Northeast Quarter of Northeast Quarter (NEW of NEW) of Section Thirty-five (35), Township Thirty-seven (37), Range Twenty-nine (29), described as follows:

Beginning at the intersection of the Westerly boundary line of Broadway Avenue in the Village of Foley with the Northerly line of said Section Thirty-five (35); thence West along said Section Line a distance of 360 feet to a point, said point being the point of beginning; thence deflect left 118°, 11.55 feet; thence East and parallel to the North line of said Section Thirty-five (35) a distance of 18.65 feet; thence at right angles North 10 feet to the North line of said Section Thirty-five (35); thence at right angles West to the point of beginning.

ALSO part of the Northeast Quarter of Northeast Quarter (NEW of NEW) of Section Thirty-five (35), Township Thirty-seven (37), Range Twenty-nine (29), described as follows:

Commencing at a point 1209.02 feet West and 10 feet South of the Northeast Corner of the Northeast Quarter of Northeast Quarter (NEW of NEW) of said Section Thirty-five (35); thence South at right angles to said Section line 246 feet; thence East at right angles 66 feet; thence North at right angles 246 feet; thence West at right angles 66 feet to the point of beginning.

Section 100:09 (3) (h). The north-south road right-of-way as it now exists easterly of and adjacent to the east line of the Southeast Quarter of the Southwest Quarter (SEM of SWM) of Section Twenty-six (26), Township Thirty-seven (37), Range Twenty-nine (29) and the east line of the Northwest Quarter (NWM) of Section Thirty-five (35), Township Thirty-seven (37), Range Twenty-nine (29), the length and easterly boundary of which is described as follows, to-wit: Beginning on the southerly line of the state highway right of way of Trunk Highway No. 23, approximately at Old Engineers Station 945+75 (Old Trunk Highway No. 25) on the east line of the Southeast Quarter of the Southwest Quarter (SEM of SWM) of Section 26, Township 37 North, Range 29 West; thence southerly along the east line of the Southeast Quarter of the Southwest Quarter (SEM of SWM) of Section 26 and the east line of the Northwest Quarter (NWM) of Section 35 to a point on the northerly line of the

state highway right of way of New Trunk Highway No. 25; said point is located approximately 360 feet north of the center of said Section 35, all in Township Thirty-seven (37) North, Range Twenty-nine (29) West Fourth Principal Meridian, Benton County, Minnesota, and there terminating.

Further, said tract of land is the southerly extension of Norman Avenue in the Village of Foley, and is herewith named Norman Avenue.

Passed and adopted at the regular meetingof the Village Council on the 55 day of September, 1972, by unanimous vote of all members present.
