WHEREAS, it is fitting for the purpose of commemorating the epochal period of 1775-1783, that a bicentennial commission be appointed to represent this state; and

WHEREAS, the government of the United States has taken formal action on July 4, 1966, to assure effective national observance of the two hundredth anniversary of the founding of this nation through the establishment of the American Revolution Bicentennial Commission;

NOW THEREFORE, I order:

- 1. the formation of the Minnesota American Revolution Bicentennial Commission to plan, encourage, develop and coordinate Minnesota's observances and activities commemorating the historic events and activities associated with the American Revolution;
- 2. the commission be composed of 28 members, appointed by the Governor, for a four year term. The co-chairmen be named by the Governor;
