

ORDINANCE NO. 426

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY  
OF HUTCHINSON AND ANNEXING THERETO CERTAIN LAND FORMERLY  
LOCATED IN THE TOWNSHIP OF Lynn

THE CITY OF HUTCHINSON DOES ORDAIN:

SECTION I. A petition has been filed with the governing body of the City  
of Hutchinson by Independent School District No. 423, being 100% owner of  
the following described real property, to have said property annexed and  
included within the corporate limits of the City of Hutchinson County of  
McLeod, State of Minnesota, to wit:

Part of the Southwest quarter of the Southwest quarter of Section 1,  
Township 116 North, Range 30 West, McLeod County, Minnesota and more  
particularly described as follows: Beginning at the Northwest corner  
of the Southwest quarter of the Southwest quarter of said Section 1,  
Township 116 North, Range 30 West; thence South along the West line  
of said Southwest quarter of the Southwest quarter of Section 1,  
Township 116 North, range 30 West for 967.78 feet; thence deflect  
left at an angle of 90° , 05' along a line parallel with the South-  
line of said Section 1, Township 116 North, Range 30 West for 657.98  
feet; thence Northerly 968.78 feet to a point on the North line of said  
Southwest quarter of the Southwest quarter of Section 1, Township 116  
North, Range 30 West, said point lying (569.25) feet East of the point  
of beginning; thence West along said North line for 659.25 feet to  
the point of beginning; covering an area of 14.62 acres more or less. ★

SECTION II. The City Council hereby determines that the annexation will  
be to the best interests of the City of Hutchinson and the territory  
affected, and that the territory described herein abuts upon the City and  
is so conditioned as properly to be subjected to City Government.

SECTION III. Therefore, the City of Hutchinson, Minnesota hereby declares  
and ordains that the property hereinbefore described be and the same is  
annexed to and included in the City of Hutchinson as effectively as if it  
had originally been a part thereof.

SECTION IV. This ordinance shall be final and shall take effect and be in  
force from and after its passage and publication and after filing a  
certified copy thereof with the Minnesota municipal Commission, McLeod  
County Auditor and the Secretary of State for the State of Minnesota.

Adopted by the City Council this 12th day of September, 1972.
