




ORDER FOR RETIREMENT


WHEREAS, The Honorable Raymond T. Olsen, Judge of the Probate Court of Isanti County, State of Minnesota, has heretofore filed with the undersigned Governor of the State of Minnesota his written application for retirement, said application being made under and pursuant to the provisions of Minnesota Statutes, Section 490.12 (1971), and


WHEREAS, the said Judge Raymond T. Olsen has submitted evidence that he has attained the age of 68 years, and has served as such judge, or as such judge and as such judge of a court of record, for more than 24 years,

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the State of Minnesota, acting pursuant to the provisions of M.S. 490.12, do hereby order and direct the retirement of the Honorable Raymond T. Olsen, to become effective at midnight on December 31, 1972. He shall become entitled thereafter to retirement compensation as provided under the law, and I further direct that this Order be filed in the Office of the Secretary of State of the State of Minnesota.

Dear Governor Anderson:

Since January, 1937, I have served continuously as Probate and County Judge in Isanti County for a period of 35 years, ending December 31, 1972. I passed my 68th birthday last October 27th, having been born October 27, 1904.

I desire to retire from my office as Judge under the provisions of, and benefits provided by Section 490.12 of the Statutes referring to the retirement of Probate Judge, and I seek your consent, asking that the same become effective as of midnight on December 31, 1972.

Since the establishment of the County Court, I am not positive as to whom I should notify as to my plans for retirement. Therefore, I am notifying not only you, but Honorable George E. Sausen, Chief Judge of County Court, Chisago, Isanti & Pine Counties.
