Village Of Mayer Ordinance 50

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF MAYER, CARVER COUNTY, MINNESOTA TO INCLUDE CERTAIN PLATTED LANDS.

Whereas a petition dated May 30, 1972 requesting annexation of the territory described below was duly presented to the Council on the 30th day of May 1972;

And Whereas it appears that the said petition is proper and that no objections have been raised and that both the Waconia Township Board of Supervisors and the Carver County Board of Commissioners have waived the 60 day waiting period.

The Common Council of the Village of Mayer, Carver County Minnesota Ordains:

Section 1. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to Village Government.

Section 2. The corporate limits of the Village of Mayer are hereby extended to include the territory as follows:

All that part of the Northwest Quarter of Section 6, Township 116, Range 25, Carver County, Minnesota, lying southerly of Honebrink's 2nd Addition and Ohm's Addition to Mayer; westerly of a line parallel with and 1795.58 feet easterly of the West line of said Northwest Quarter as measured along the North line of said Northwest Quarter; northerly of the northerly right-of-way line of the Burlington Northern Railway; and easterly of a line parallel with the West line of the said Northwest Quarter and 464.21 feet easterly of the Southwest corner of Lot 1, Block 4, Honebrink's 2nd Addition.

And That part of the Northwest Quarter of Section 6, Township 116, Range 25, Carver County, Minnesota, described as follows: Commencing at the Northwest corner of said Northwest Quarter; thence East along the North line of said Northwest Quarter a distance of 1795.58 feet; thence South parallel with the West line of said Northwest Quarter a distance of 1354.66 feet to the point of beginning; thence continuing South parallel with said West line 324.46 feet more or less to the northerly right-of-way line of the Great Northern Railroad; thence East along said right-of-way line 339.43 feet more or less to its intersection with the East line of said Northwest Quarter; thence North along said East line 918.56 feet more or less to its intersection with a line drawn parallel with and 1354.66 feet South of the North line of said Northwest Quarter; thence West along said parallel line 329.15 feet more or less to the point of beginning, containing 7.072 acres more or less.

Section 3. The Village Clerk is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, The Carver County Auditor, The Secretary of the State of Minnesota and the Town Clerk of Waconia Township, Carver County, Minnesota.

Section 4. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 3, above.


