AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS COMPLETELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, said land is completely surrounded by land within the municipal boundaries of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Beginning at the Northwest corner of Section 14, Township 30 North, Range 22 West; thence Southerly along the West line of the Northwest 1/4 of said Section 14 for a distance of 928.4 feet; thence Westerly along the North line of Lot 040-04, Section 15, Township 30, Range 22 West, a distance of 265 feet; thence Southerly along the West line of said lot of said Section 15 for a distance of 400 feet to the centerline of Ninth Street; thence Easterly along said centerline for a distance of 1, 254.72 feet; thence Northerly along the East line of Lot 020-25 of said Section 14 for a distance of 1,328.4 feet to the North line of Section 14; thence Westerly along the North line of said Section 14, for a distance of 990.38 feet to the point of beginning and there terminating.

2. That this Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of State of Minnesota and Clerk of Town of White Bear.
