ORDINANCE NO. 192

AN ORDINANCE ANNEXING TO THE CITY OF MARSHALL CERTAIN LAND OWNED BY IT.

The Common Council of the City of Marchall do ordain as follows:

Section 1. The parcols of real estate hereinafter described which are owned by the City of Marshall and which abut on the corporate limits thereof, are hereby annexed to said City.

Section 2. Said real estate so amexed is located in the County of Lyon, State of Minnesota and is described as follows to-wit:

The Southeast Quarter of Section 6, Township III North, Range 41 West, and the west 664 feet of the Southwest Quarter of Section 5, Township III North, Range 41 West, containing 205.25 acres more or less

and.

All that part of the Northeast Quarter of Section 6, Township III North, Range 41 West, described as Tollowa, to-wit: Beginning at the center of Section 6; thence north on the north-south quarter line 1260.0 feet; thence southeasterly to a point on the east-west quarter line 1460 feet east of the center of said section; thence west on the east-west quarter line 1460.0 feet to the center of said Section 6, the point of beginning, containing 21.12 acres more or less

and

That portion of the property located in the Northeast Quarter of the Southwest Quarter of Section 6, Township III North, Range 41 West beginning at the center of said Section 6; thence west on the east-west quarter line approximately 120 feet; thence south 50° 02° east to a point on the north-nouth quarter line; thence north on the quarter line approximately 120 feet to the point of beginning. AND that property located in the Northwest Quarter of Section 0, Township 111 North, Range 41 West beginning at the center of said Section 6: thence west on the east-west quarter line approximately 120 feet; thence north 50° 02° west approximately 3,120 feet to a point on the west section line of said Section 6; thence north on the west section line approximately 660 feet to the northwest corner of said Section 6; thence east on the north section line approximately 760 feet: thence south 50° 02' east approximately 2,250 feet to the point on the north-south quarter line; thouce south approximately 1,250 feet to the center of said Section 6 to the point of beginning, containing 70.1 acres, more or less.

Section 3. This ordinance shall take effect from and after its adoption and publication, and from and after a certified copy thereof has been filed with the Minnesota Municipal Commission, the Town Clerk of Lake Marshall Township, the County Auditor of Lyon County and the Secretary of State.
