ORDINANCE NO. 255 NEW SERIES
AN ORDINANCE ANNEXING REAL PROPERTY
TO THE CITY OF BLUE EARTH

BE IT ORDAINED By the City Council of the City of Blue Earth, as follows:

Section 1.

It is recited that there has heretofore been filed with the City of Blue Earth, Faribault County, Minnesota, a municipal corporation, a petition signed by all of the owners requesting the annexation of that certain tract of land located in the County of Faribault and State of Minnesota, more fully described as follows, to-wit:

That portion of the South Half of the Northeast Quarter being in Section 20 in Township 102 North, Range 27 West of the Fifth Principal Meridian in Faribault County, Minnesota lying West of the Westerly right-of-way line of the Chicago and Northwestern Railroad Company, excepting therefrom a tract bounded by a line commencing 80 rods South of the Northwest Corner of the Northeast Quarter of Section 20 in Township 102 North of Range 27 West of the Fifth Principal Meridian, and running thence East 40 rods, thence South 12 rods, thence West 40 rods, thence North 12 rods to point of beginning.

The East 33 feet of the Southeast Quarter of the Northwest Quarter of Section 20 in Township 102 North, Range 27 West of the Fifth Principal Meridian in Faribault County, Minnesota excepting therefrom the North 48 rods.

Section 2.

It is hereby determined that all of the owners of said tract of land have signed said petition; that no objections to said annexation have been filed with the Minnesota Municipal Commission and that said land is unplatted and does not exceed Two Hundred (200) acres; and that annexation thereof to the City of Blue Earth will be in the best interest of the municipality and the territory affected. It is further determined that proper service has been made upon all other municipal corporations.

Section 3.

It is Hereby declared pursuant to the provisions of law applicable thereto; that said tract of land described in Paragraph 1 above be and the same hereby is annexed to the City of Blue Earth, a municipal corporation.

Section 4.

This Ordinance shall be in force and effect after its passage and publication as required by law.
