AN ORDINANCE DECLARING CERTAN PLATTED LAND TO BE ANNEXED TO TIE CITY DF NORTT MANKATO AND PROVIDING ZONING THEREFOR.


#### Abstract

The Common Council of the City of North Mankato, Minmesota, does ordain as follows:


Sec. 1. Lot 14, Forest Heights, Nicollet Councy, Minnesota, according to the plat thercof on file and of record in the office of the Register of Deeds within and for Nâcollet County, Minnesota and any and ail streets, highways or other public rights of way within and adjacent to said described land, is hereby annexed and declared co be a part of the City of North Mankato and to be included in the corporate limits thereof.

Sec. 2. The above described land be and hereby is zoned R-1. Single Family Residence District, pursuant to the Zoning Ondinance of the City of North Mankato.

Scc. 3. This ordinance shall take effect from and after its date of passage and publication.
