ORDINANCE NO. 352

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF DETROIT LAKES TO INCLUDE CERTAIN LAND

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section I. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, signed by all of the owners of the following described land included within the City of Detroit Lakes, Minnesota:

A tract of land located in Section Twenty-six (26), Township One Hundred Thirty-nine (139) North, Range Forty-one (41) West of the Fifth Principal Meridian, described as follows:

Beginning at a point 216.5 feet South of the Northwest Corner of the Northwest Quarter of the Northwest Quarter of said Section 26; thence East a distance of 215 feet; thence South a distance of 180 feet; thence West a distance of 215 feet; thence North a distance of 180 feet to the point of beginning.

Section II. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as property to be subjected to the city government.

Section III. Therefore, the City of Detroit Lakes, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.

Section IV. The City Council hereby determines that there are thirty-two (32) persons living in the area to be annexed.

Section V. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State, and from and after its passage and publication.
