ORDINANCE NO. 257

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINDOM TO INCLUDE CERTAIN UNINCORPORATED PLATTED AND UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated July 14, 1972 requesting annexation of the territory hereinafter described was duly presented to the Council on the 31st day of July, 1972; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 41 acres of platted and unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by 45 owners, constituting a majority but not all of a total number of 80 owners; and

WHEREAS, no objections to the annexation have been received from the town board or county board; and

WHEREAS, the boundaries of the land to be annexed do not abut upon the boundaries of any other municipality; and

WHEREAS, a hearing was duly held by the City Council of the City of Windom, Minnesota on the proposed annexation after at least 30 days mailed notice; and

WHEREAS, the land described in the petition abuts upon the city limits at the west boundary thereof;

BE IT ORDAINED BY THE CITY OF WINDOM, MINNESOTA AS FOLLOWS:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory annexed. The corporate limits of the city are hereby extended to include the platted and unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

- (A) All of Riverdale Subdivision in Great Bend Township.
- (B) All of Horkey's Subdivision in Great Bend Township.
- (C) All that part of the Southeast Quarter of Section 22, Township 105, Range 36, bounded by the following lines:

On the North by the North line of said Southeast Quarter of Section 22.

On the West by the East line of Horkey's Subdivision in Great Bend Township.

On the South by the Center line of County State Aid Highway #13.

On the East by the East line of said Section 22.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Great Bend Town Clerk, the Secretary of State and the County Auditor.

Section 4. Effective date. This ordinance takes effect upon its passage and publication and the filing of the Certified copies as directed in Section 3.
