ORDINANCE NO. 548

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, sixty percent (60%) or more of the perimeter of this territory is bordered by land already included within the corporate limits of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be in the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Lots 1, 2 and 3, Block 1, Oak Grove Addition in Section 23-30-22; also, the west 220.42 feet of the east 581.28 feet of that part of the northeast $\frac{1}{4}$ of the southeast $\frac{1}{4}$ of said Section 23 lying north of the north R/W of South Shore Boulevard; also, the east 80.43 feet of that part of the northeast $\frac{1}{4}$ of the southeast $\frac{1}{4}$ of said Section 23 lying north of the north R/W of South Shore Boulevard; also, the north $\frac{1}{2}$ of the R/W of South Shore Boulevard lying between the West line of Lot 3, Block 1, Oak Grove Addition and the east line of said Section 23; also, that portion of the northwest $\frac{1}{4}$ of the southwest $\frac{1}{4}$ of Section 24-30-22 lying north of the north R/W of South Shore Boulevard, between the west line of said Section 24 and the east line of Thome's Lakeridge No. 1 extended northerly to the shore of White Bear Lake; also, that part of the northwest $\frac{1}{4}$ of the southwest $\frac{1}{4}$ of Section 24 lying within the R/W lines of South Shore Boulevard; also, the east $\frac{1}{2}$ of the R/W of McKnight Road, between South Shore Boulevard and the south line of Thome's Lakeridge No. 1 extended westerly to the west line of Section 24; also, that part of the west $\frac{1}{2}$ of the southwest $\frac{1}{4}$ of Section 24 lying within the R/W lines of Lilac Lane.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of the State of Minnesota and the Clerk of the Town of White Bear.

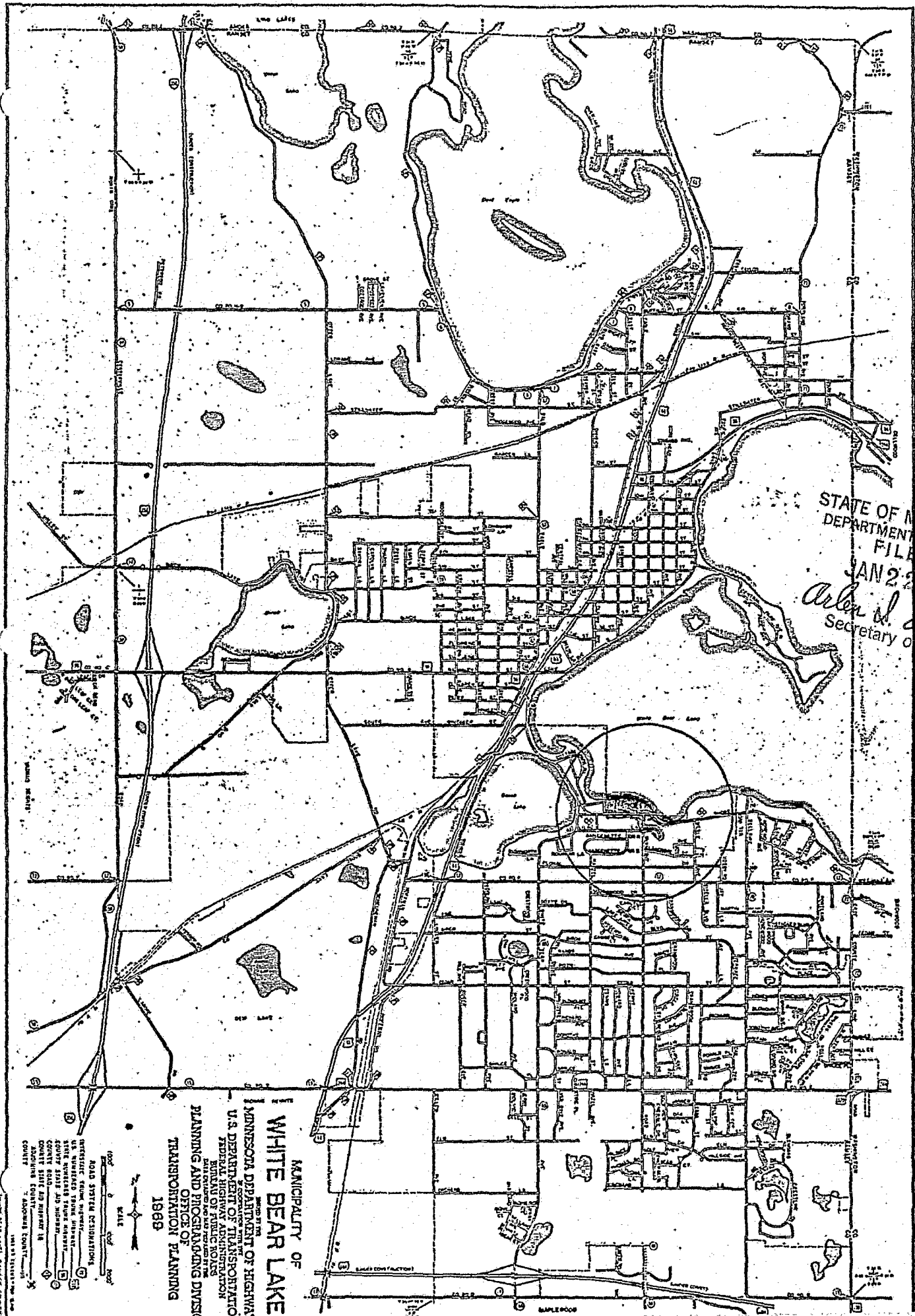
