## ORDINANCE NO. 432

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council on the 7th day of August, 1972; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 12.57 acres, more or less, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by Abner Nelson, he being the sole owner of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the Town Board or County Board; and

WHEREAS, the land described in the petition abuts upon the city limits near the northwesterly corner thereof;

The City of Montevideo does ordain:

<u>Section 1.</u> The City Council hereby determines: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

<u>Section 2. Territory Annexed:</u> The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

All of the Southeast Quarter of the Northeast Quarter (SE4 NE4) of Section Twelve (12), Township One Hundred Seventeen (117) North, Range Forty-one (41) West, lying east of the new right of way of the Chicago, Milwaukee and St. Paul Railway Company and that part of the Northeast Quarter of the Southeast Quarter (NE4 SE4) of said Section Twelve (12) which lies east of said new right of way of the Chicago, Milwaukee and St. Paul Railway Company and north of a line that is 712.20 feet north of and parallel to the south line of said Northeast Quarter of the Southeast Quarter (NE4 SE4) of said Section Twelve (12), containing 12.57 acres, more or less.

Section 3. That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as I2 - "Industrial District".

Section 4. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Register of Deeds.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
