



ORDINANCE NO. 503

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota, by the sole owners of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

A part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 33, Township 112 North, Range 41 West, described as follows: Commencing at a point 15.15 feet south 44° 20' west of the intersection of the centerline of North Fourth Street (County Road No. 67) with the centerline of North Bruce Street (East Section Line of Section 33); thence north 45° 40' west a distance of 141.40 feet to the true point of beginning; thence north 45° 38' west a distance of 374.60 feet; thence south 44° 22' west a distance of 140.00 feet; thence north 45° 38' west a distance of 102 $\frac{1}{2}$ feet to the center of the old channel of the Redwood River; thence southwesterly on the center of said old channel a distance of approximately 108 feet; thence south 45° 48' east a distance of approximately 599.21 feet to the west right of way line of County Road No. 67; thence north 44° 20' east a distance of 172.00 feet; thence north 45° 40' west a distance of 108.40 feet; thence north 45° 20' east a distance of 75.0 feet to the point of beginning, containing 3.0 acres, more or less.

A parcel of land in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 33, Township 112 North, Range 41 West, described as follows: Commencing at a point 15.15 feet south 44° 20' west of the intersection of the centerline of North Fourth Street (County Road No. 67) with the centerline of North Bruce Street (East Section Line of Section 33); thence north 45° 40' west a distance of 41.40 feet to the true point of beginning; thence continuing on same said line a distance of 100.0 feet; thence south 45° 20' west a distance of 75.0 feet; thence south 45° 40' east a distance of 108.50 feet; thence north 37° 57' east a distance of 75.2 feet to the point of beginning, containing 0.18 acres, more or less.

A portion of County Road No. 67 right of way in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 33, Township 112 North, Range 41 West described as follows: Beginning at a point 15.15 feet south 44° 20' west of the intersection of the centerline of North Fourth Street (County Road No. 67) with the centerline of North Bruce Street (East Line of Section 33); thence north 45° 40' west a distance of 41.40 feet; thence south 37° 57' west a distance of 75.2 feet; thence south 44° 20' west a distance of 172.0 feet; thence south 45° 38' east a distance of 66.0 feet; thence north 44° 20' east a distance of approximately 230 feet to a point of intersection with the centerline of North Bruce Street (East Section Line of Section 33); thence north on the centerline of North Bruce Street (East Section Line of Section 33) a distance of approximately 25 feet; thence north 45° 40' west a distance of approximately 16 feet to the point of beginning, containing approximately 0.37 acres.

Section 2. This quantity of land embraced within the foregoing description as bounded and described, is 3.55 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota, and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 4. Therefore, the City of Marshall, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if they had been originally a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Lake Marshall Township, the County Auditor of Lyon County and the Secretary of State, and from and after its passage and publication.
