ORDINANCE NO. 368

BE IT ORDAINED By the City Council of the City of Litchfield as

follows:

SECTION 1. That the following territory be and hereby is annexed to and incorporated in the corporate limits of the City of Litchfield, Macker County, Minnesota:

A part of the Northeast Quarter (NEA) of Section Thirteen (13), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W), described as follows: The West 437 feet of all that part of the Northeast Quarter (NEA) of Section Thirteen (13), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W), lying North of the northerly right of way line of Minnesota State Trunk Highway No. 12, as said highway is now located, excepting therefrom the following described tract: Beginning at a point 150 feet East and 241.1 feet South of the guarter corner on the North side of said Section Thirteen (13), Township One Hundred Nineteen North (119-N), Range Thirty-one West (31-W), thence South 107,6 feet to the northerly right of way line of Trunk Highway No. 12, thence in a Southeasterly direction along the northerly right of way line of said Trunk Highway No. 12, 300 feet, thence North 195.5 fest, thence West 287.0 feet to the point of beginning, said exception containing one (1) acre and being the tract of land described in Book 275 of Deeds at pages 449-450 in the office of the Register of Deeds in and for Meeker County, Minnesota.

SECTION 2. This ordinance shall be in effect from and after its final passage and publication.
