

ORDINANCE NO. 85

An Ordinance extending the corporate limits of the Village of Chisago City, Minnesota.

WHEREAS the territory described below is not presently within the corporate limits of any incorporated, city, village or borough, and,

WHEREAS the sole owners of the property described below petitioned the Village Council of the Village of Chisago City, Minnesota on the 24th day of August, 1972 to annex the same to the Village of Chisago City, and,

WHEREAS, by resolution adopted by the Village Council on October 17, 1972 and served upon the Chisago County Board of Commissioners, the Chisago Lakes Township Board and the Minnesota Municipal Commission by mailing a copy of same to each of them on the 23rd day of October, 1972, the said Village Council expressed its intention to annex the territory described below to said Village, and,

WHEREAS no objections have been received from any party as to the proposed annexation.

NOW THEREFORE the Village Council of the Village of Chisago City, Chisago County, Minnesota ordains as follows:

SECTION 1. The corporate limits of the Village of Chisago are hereby extended to include the property legally described as follows:

Lots Four (4) and Five (5), the South Twelve (12) feet of Lot Six (6), the South Twelve (12) feet of the Easterly Twenty (20) feet of Lot Eleven (11) and the Easterly Twenty (20) feet of Lots Twelve (12) and Thirteen (13), Block Forty-two (42) of Chisago City.

Lots Thirteen (13) and Fourteen (14) and the South Half (S $\frac{1}{2}$) of Lot Twelve (12), Block Forty-three (43), Chisago City.

Including all streets and alleys abutting thereto.

SECTION 2. The Village Clerk is directed to file certified copies of this Ordinance, together with the Affidavit of Publication thereof, with the Secretary of State, the County Auditor of Chisago County, Minnesota and the Minnesota Municipal Commission.

SECTION 3. This Ordinance takes effect upon its passage and publication according to law.




