LEGAL PUBLICATION

ORDINANCE NO. 169

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LE CENTER TO INCLUDE CERTAIN UNINCORPORATED PLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS

WHEREAS, a petition requesting the annexation of the territory hereinafter described was duly presented to the Village Council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is less than 200 acres of platted land, no part of which is included within the limits of any incorporated city, village, or borough; and

WHEREAS, the petition was signed by a majority of the owners of said land; and

WHEREAS, no objections to the annexation has been received from the town boards, the county boards, or the governing body of any municipality whose boundaries abut upon the boundaries of the lands to be annexed; and

WHEREAS, the land described in the petition abuts upon the village limits at the West boundaries thereof;

NOW, THEREFORE, the Council of the Village of Le Center, Minnesota, ordains:

SECTION 1 - The Village Council hereby determines (1) that the annexations will be to the best interests of the village and of the territories affected; (2) that the territories described herein abuts upon the village limits and is urban or suburban in character; and (3) that none of said territories are now included within the limits of any city, village, or borough.

SECTION 2 - Territory annexed. The corporate limits of the village are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

Parcel I, owned by Joseph Garvin described as follows, to-wit:

Lots 1 and 2, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel II, owned by Clayton Simonette and Jacqueline Simonette, husband and wife, described as follows, to-wit:

Lot 4, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel III, owned by Michel Simonette, described as follows, to-wit:

Lot 3, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel IV, owned by Clayton Simonette, Jr., described as follows, to-wit:

Lot 5, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel V, owned by Ed Lex described as follows, to-wit:

Lot 6 and North 10 feet of Lot 7, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel VI, owned by Vince McCabe, described as follows, to-wit:

Lot 8 and South 40 feet of Lot 7, Block 4, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel VII, owned by Jerry Machacek, described as follows, to-wit:

Lots 12 and 13, Block 3, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel VIII, owned by Larry Blaschko described as follows, to-wit:

Lots 14 and 15, Block 3, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel IX, owned by George Blaschko described as follows, to-wit:

Lot 16, Block 3, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel X, owned by David Kahl described as follows, to-wit:

North Half of Lot 10 and all of Lot 11, Block 3, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

Parcel XI, owned by Wayne Kewitsch described as follows, to-wit:

Lot 9 and South Half of Lot 10, Block 3, Maple Grove Addition to the Village of Le Center, Le Sueur County, Minnesota.

SECTION 3 - Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4 - Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

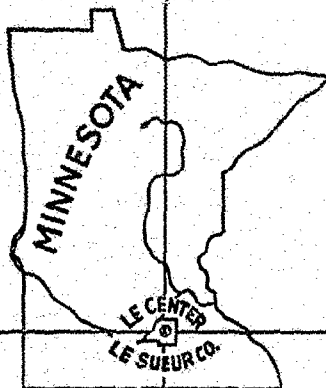
