REORGANIZATION ORDER NO. 18

Pursuant to Minnesota Statutes 16.125, 16.13 and 16.135 the following administrative reorganization is hereby made:

The functions of the Liquor Control Commissioner related to the collection of liquor, wine, and beer taxes from wholesalers, distillers, importers, brewers, common carriers and such others as may be referenced by statutes are hereby transferred to the Commissioner of Taxation.

The following positions and their incumbents are hereby transferred with all accrued benefits from the Department of Liquor Control to the Department of Taxation.

Law Enforcement Inspector	Justus Widholm
Law Enforcement Inspector	James Barthel

The approved complement of the Department of Liquor Control is hereby decreased by four positions and the approved complement of the Department of Taxation is hereby increased by four positions.

The salaries and supplies expense for these positions are hereby transferred from the Department of Liquor Control, Salaries (21600:01-100) and Supply and Expenses (21600:02-100) to the Department of Taxation, Salaries (13300:01-100) and Supply and Expenses (21600:02-100) as follows:
