ORDINANCE NO. 1443  
AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Lands not Exceeding 200 Acres in Area, all Being in Section 32, Township 107 North, Range 14 West, Olmsted County, Minnesota.

THE COMMON COUNCIL OF THE CITY OF ROCHESTER DO ORDAIN:

Section 1. The City of Rochester, Minnesota, is the owner of the lands described herein, which lands abut upon the present territorial limits of the City of Rochester. The said lands owned by the City are located in Cascade Township, Olmsted County, Minnesota, and are described as follows:

That part of the Southeast Quarter and the Southwest Quarter, Section 32, Township 107 North, Range 14 West described as follows:  
Commencing at the Southeast corner of the Northwest Quarter of the Southeast Quarter of Section 32, Township 107 North, Range 14 West; thence West along the South line of the Northwest Quarter of the Southeast Quarter of said Section 32 a distance of 881.10 feet for a point of beginning; thence North a distance of 553.3 feet along a line drawn from said point of beginning to a point which is 815.0 feet westerly of the East line of the Southwest Quarter of the Northeast Quarter of said Section 32 and measured along the center line of 7th Street N.W. formerly Township Road No. 1; thence northwesterly at a deflection angle of 61°34'20" to the left a distance of 478.83 feet; thence southwesterly at right angles a distance of 331.3 feet to the beginning of a curve whose radius is 749.20 feet and delta angle is 60°29'40"; thence southwesterly deflecting to the right along said curve a distance of 495.5 feet; thence southeasterly along a line which is radial to said curve a distance of 192.5 feet to a point in the South line of the North one-half of the Southwest Quarter of said Section 32; thence East along the South line of the North one-half of said Southwest Quarter a distance of 431.65 feet to the Southeast corner of said North one-half; thence East at a deflection angle of 60°02'20" to the right along the South line of the Northwest Quarter of the Southeast Quarter of said Section 32 a distance of 428.0 feet to the point of beginning, being subject to an easement, of record, to the Northwestern Bell Telephone Company running East and West near the southerly boundary of the above described tract.

Section 2. The quantity of land described in Section 1 is approximately 11.15 acres.

Section 3. The Common Council of the City of Rochester hereby determines that the lands described in Section 1 abut the present territorial limits of the City of Rochester and are hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if they had originally been a part thereof.

Section 4. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Clerk of the Town of Cascade, the Olmsted County Auditor and the Secretary of State.
