ORDINANCE NO. 550

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, The land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, sixty percent (60%) or more of the perimeter of this territory is bordered by land already included within the corporate limits of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

The north 295 feet of the east 295 feet of the northeast $\frac{1}{4}$ of the southeast $\frac{1}{4}$ of Section 36-20-22.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of the State of Minnesota and the Clerk of the Town of White Bear.

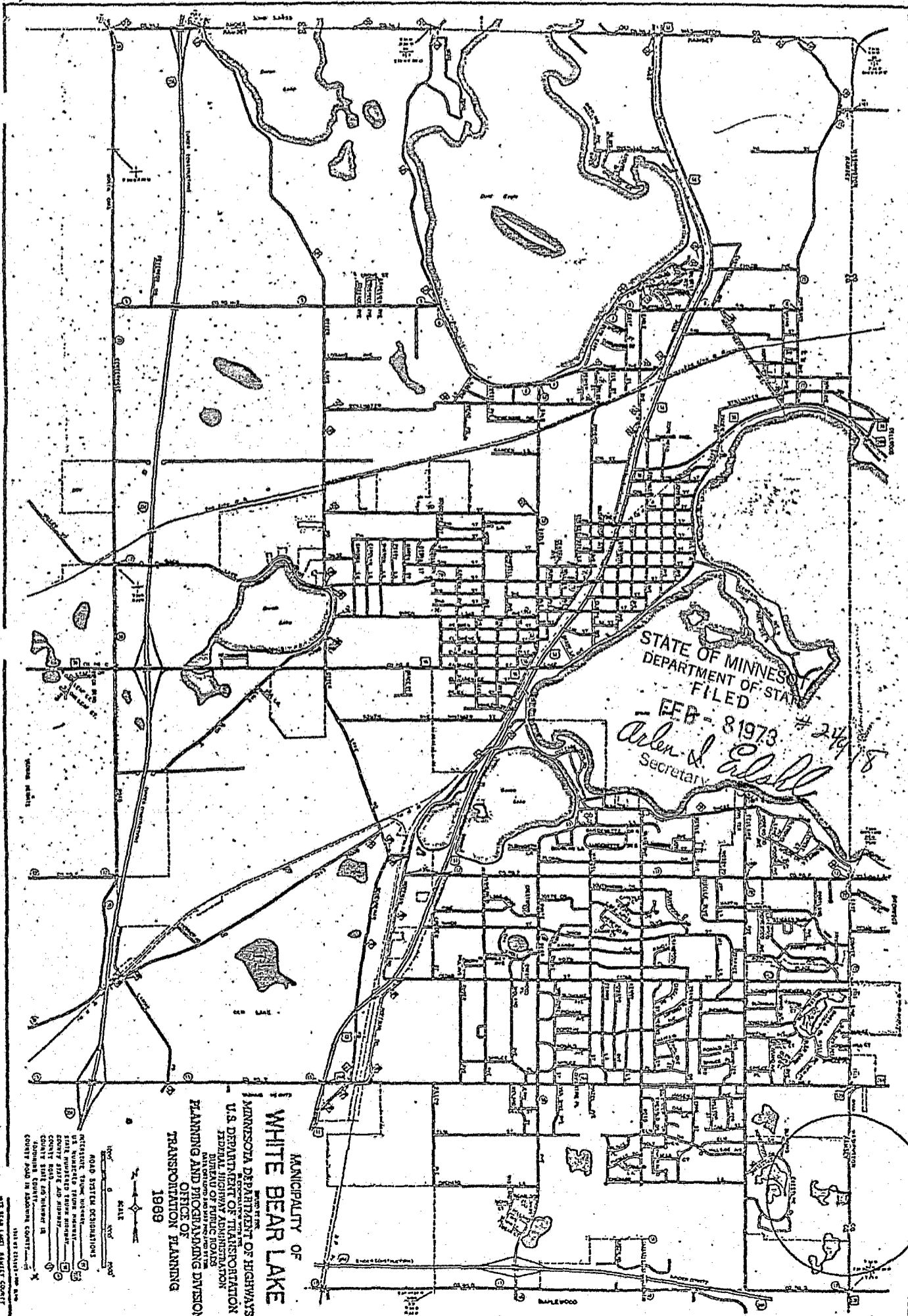
