

ORDINANCE NO. 353

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA
TO INCLUDE CERTAIN LANDS

THE COUNCIL OF THE CITY OF DETROIT LAKES, MINNESOTA, DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the City of Detroit Lakes, Minnesota, by W. H. Long, sole owner of the following described real estate, to have such land included within the City of Detroit Lakes, Minnesota:

A 3.537 acre tract of land in the Southeast Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$), Section Twenty-six (26), Township One Hundred Thirty-nine (139) North, Range Forty-one (41) West of the Fifth Principal Meridian, described as follows, to-wit:

Beginning at a point on the South line of the Northwest Quarter (NW $\frac{1}{4}$), Section Twenty-six (26), Township One Hundred Thirty-nine (139) North, Range Forty-one (41) West of the 5th Principal Meridian; that is, 1660.50 feet East of the Southwest Corner of the Southwest Quarter (SE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 26; thence North at right angles a distance of 770.40 feet; thence East at right angles a distance of 200 feet; thence South a distance of 770.40 feet; thence West along the South line of the Northwest Quarter (NW $\frac{1}{4}$) of said Section 26 to the point of beginning.
Cont ins 3.537 acres.


Section 2. The City Council hereby determines: (1) that the annexation will be in the best interests of the City of Detroit Lakes, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City of Detroit Lakes and is so conditioned as property to be subjected to the city government.

Section 3. Therefore, the Council of the City of Detroit Lakes, Minnesota hereby ordains and declares that the property hereinbefore described be and the same hereby is annexed to, and included in the City of Detroit Lakes, Minnesota, as effectually as if it had originally been a part thereof.


Section 4. This Ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor, the Clerk of the Town Board, and the Secretary of State, and from and after its passage and publication.



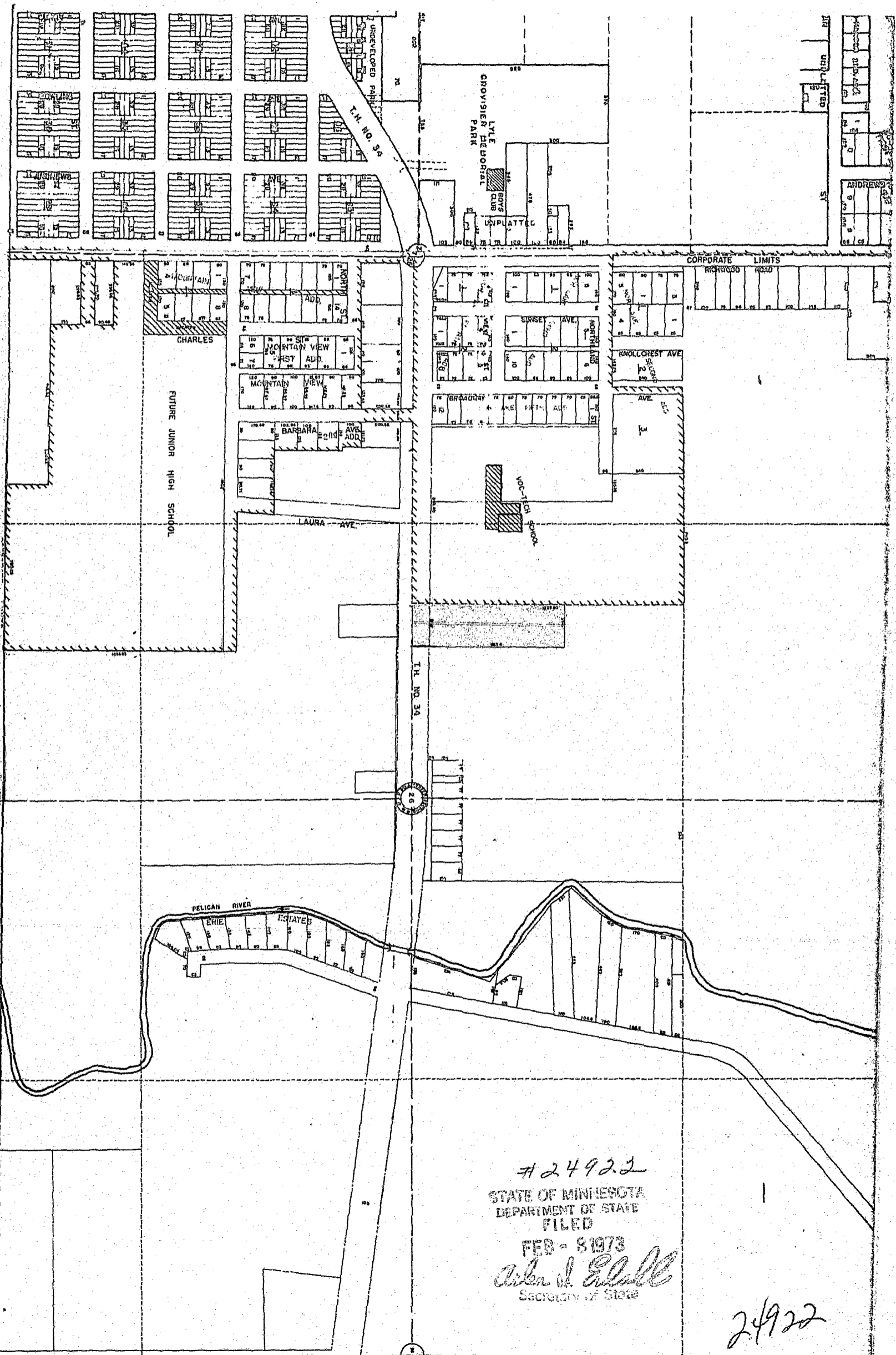
