ORDINANCE NO. 1-73

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BROWERVILLE TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 18, 1972, requesting annexation of the territory hereinafter described was duly presented to the Council on the 21st day of September, 1972, and

WHEREAS, the quantity of land embraced with the area described in the petition and bounded as described is less than two hundred (200) acres of unplatted land, being approximately 1.5 acres, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners of said property, and

WHEREAS, no objection to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the land to be annexed, and

WHEREAS, a copy of said petition was filed with the Town Clerk of Hartford Township, on September 20, 1972, and sixty days have lapsed since the filing and no objections have been filed by the Township, and

WHEREAS, the land described in the petition abuts upon the City limits at the south boundary thereof:

The Council of the City of Browerville, Minnesota, ordains:

Section 1. The City Council hereby determines:

- (a) That the annexation will be to the best interests of the City, and of the territory affected.
- (b) That the territory described herein abuts upon the City limits and is urban or suburban in character.

- (c) That none of the territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included in the City as effectually as if it had originally been a part thereof.


Commencing at a point 366 feet south and 110 feet west of the Northeast corner of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section 8, Township 130, North, Range 33 west of 5th P.M. thence south 300 feet, thence west 150 feet thence North 300 feet, thence east 150 feet, to the place of beginning, all according to the United States Government Survey thereof.

Commencing at a point 366 feet south of the Northeast corner of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section 8, Township 130 North, Range 33, west of the 5th P.M. thence south 300 feet, thence west 110 feet, thence north 300 feet, thence east 110 feet to the place of beginning, all according to the United States Government Survey thereof.


Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.


Section 4. Effective Date. This ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
