ORDINANCE NO. 438

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN  
LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 23.4 acres, more or less, of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners of the territory therein described; and

WHEREAS, copies of such petition have been filed with the Town Board of Sparta Township, the County Board of Chippewa County, and the Municipal Commission of the State of Minnesota, proof thereof being on file with the City Clerk of the City of Montevideo; and

WHEREAS, more than sixty (60) days have elapsed since such filing and no objections have been received under Minnesota Statutes 414.033, subdivision 5; and

WHEREAS, the land described in the petition abuts upon the city limits at the easterly boundary thereof;

THE CITY OF MONTEVIDEO DOES ORDAIN:

Section 1. Determination by the City Council: The City Council hereby determines: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

A parcel of land in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$  SW $\frac{1}{4}$ ) and the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section Five (5), Township One Hundred Seventeen (117) North, Range Forty (40) West, County of Chippewa 300 feet in width on each side of and parallel to a center line described as follows:

Beginning at a point on the north line of the South Half of the Southwest Quarter (S $\frac{1}{2}$  SW $\frac{1}{4}$ ) of said Section Five (5) that is 2116.6 feet east of the center line of Minnesota Trunk Highway No. 29 as now located approximately along the west line of said Section Five (5); thence southeasterly on a straight line to a point on the south line of said Section Five (5) that is 3203.9 feet east of the southwest corner of said Section Five (5).

And, also a strip of land 35.4 feet in width lying parallel to and contiguous to the northeasterly line of the above described parcel, containing 23.4 acres, more or less.

Section 3. Zoned for airport purposes: That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned for use as part of Montevideo Chippewa County Airport.

Section 4. Filing: The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Town Clerk of Spara Township, the Secretary of State of the State of Minnesota, the County Auditor and the Register of Deeds of Chippewa County.

Section 5. Effective Date: This ordinance shall take effect upon its passage and publication and the filing of the certified copies as directed in Section 4.

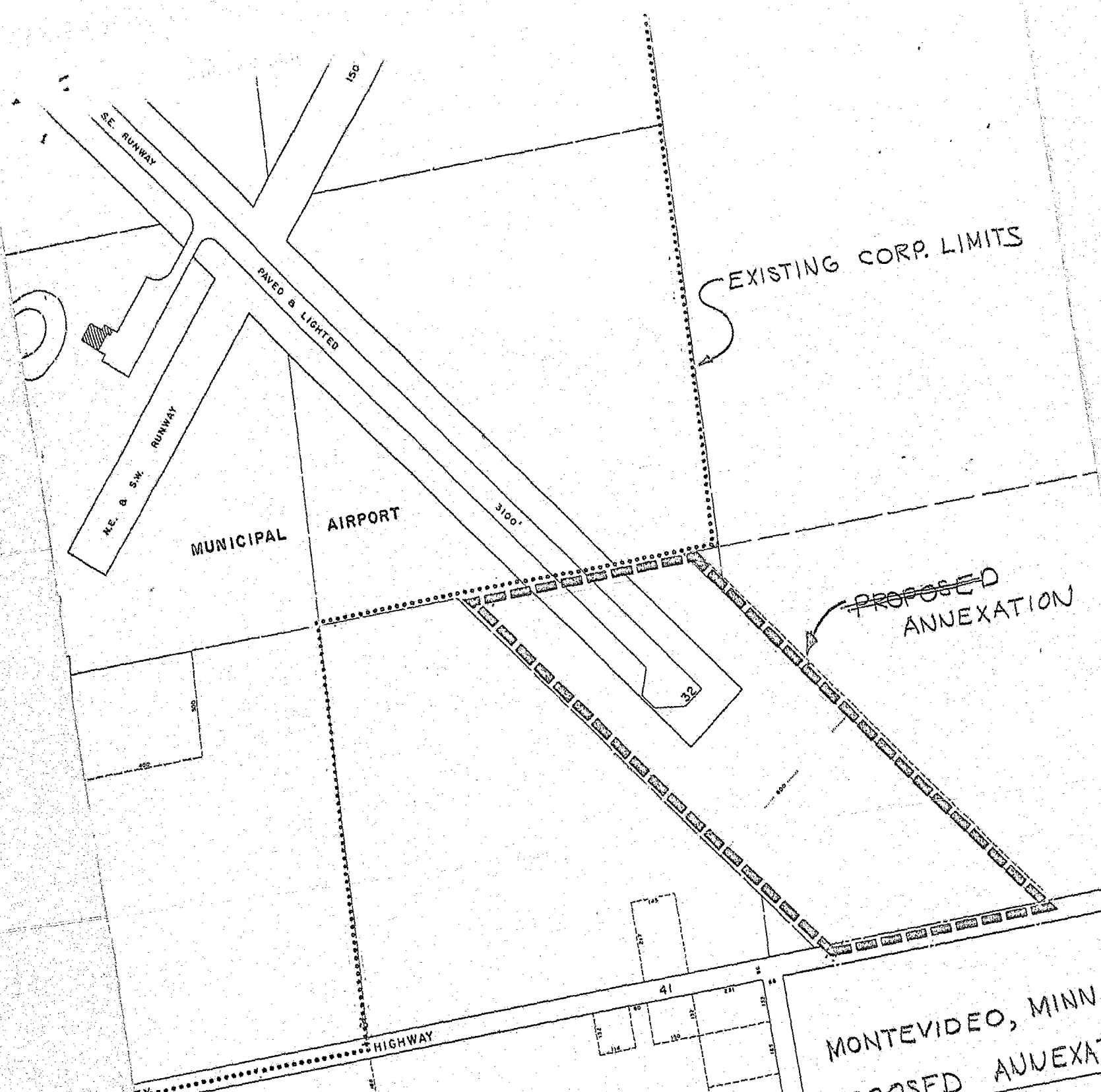
