#### ORDINANCE NO. 55

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF LONSDALE TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY AND ABUTTING UPON THE LIMITS OF THE VILLAGE OF LONSDALE.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village, or borough; and WHEREAS, this territory abuts upon the corporate limits of the Village of Lonsdale at the south boundary thereof and is deemed to be urban in character; and

WHEREAS, this territory is owned in fee by the Village of Lonsdale;

The Village Council of Lonsdale ordains:

Section 1. Territory Annexed. The corporate limits of the Village of Lonsdale are hereby extended to include the unplatted property described as follows now owned by the Village of Lonsdale:

Parcel 1. All that land lying within the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of Section 26, Township 112 North, Range 22 West and lying North and East of the following described line: Commencing at a point on the North line of the Southeast Quarter (SE 1/4) of the Southeast Quarter (SE 1/4) of Section 26, Township 112 North, Range 22 West, being 187 feet from the Northeast Corner (NE Cor) of said Southeast Quarter (SE 1/4) of Southeast Quarter (SE 1/4), thence Southeasterly to a point on the East line of said Southeast Quarter (SE 1/4) of Southeast Quarter (SE 1/4) of Southeast Corner (NE Cor) of said Southeast Quarter (SE 1/4) of Southeast Quarter (SE 1/4) and there ending, all in Rice County, Minnesota.

Parcel 2. The Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of the Southwest Quarter (SW 1/4) of Section 25, Township 112 North, Range 22 West of the Fifth Principal Meridian, containing 10 acres more or less.

Parcel 3. The Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of Section 25, Township 112 North, Range 22 West of the Fifth Principal Meridian; ALSO together with a permanent easement 75 feet in width over and across a piece of land in the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of Section 25, Township 112 North, Range 22 West of the Fifth Principal Meridian, in the Village of Lonsdale, Rice County, Minn., described as follows, to-wit: Commencing at the Southwest Corner of the said Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4); thence running North 75 feet; thence running Southeasterly to a point on the South line of said Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4), 75 feet East of the point of

Beginning; thence West 75 feet on said South Line of Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4), to the point of beginning.

Section 2. Filing. The Village Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Rice County, the Minnesota Municipal Commission and the Town Clerk of WHEATLAND Township, Rice County, Minnesota.


