pletely surrounded by land within the municipal limits of the City of Staples:

Block Three (3), wilson's addition to Staples, including all streets, utility easements and alleys therein and abutting thereon.

bounded and described is 90,000 square feet or approximately 2.1 acres.

SECTION 3. That said area is urban in character.

ECCTION 4. The Vity Council hereby determines that the ennexation is for the best interests of the City of staples and the territory affected.
