

ORDINANCE NO. 252

AN ORDINANCE AMENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

SECTION 1. The following described tract of land is completely surrounded by land within the municipal limits of the City of Staples:

Block Three (3), Wilson's Addition to Staples, including all streets, utility easements and alleys therein and abutting thereon.

SECTION 2. The quantity of land embraced by the tract above bounded and described is 90,000 square feet or approximately 2.1 acres.

SECTION 3. That said area is urban in character.

SECTION 4. The City Council hereby determines that the annexation is for the best interests of the City of Staples and the territory affected.

SECTION 5. The City Council of the City of Staples hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota as effectually as if it had originally been a part thereof.

SECTION 6. This ordinance shall be final and shall take effect and be in force from and after the publication thereof and it is hereby directed that copies hereof be filed with the Minnesota Municipal Commission, the County Auditor and the Minnesota Secretary of State.
