ORDINANCE NO. 536

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS COMPLETELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, said land is completely surrounded by land within the municipal boundaries of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Beginning at the Southeast corner of Lot 040-40, Govt. Lot 2, Section 15, Township 30 North, Range 22 West; thence Northerly along East line of said lot of said Section 15 to a point 902.24 feet South of the North line of the Southeast 1/4 of the Northwest 1/4 of Section 15; thence Westerly for a distance of 200 feet to the Northwest corner of Lot 020-40, Govt. Lot 2, of said Section 15; thence Southerly along the West line of said lot, of said Section 15, to the Southwest corner of said Lot 020-40; thence Easterly along the South line of Lots 020-40 and 040-40 to the point of beginning and there terminating.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of State of Minnesota and Clerk of Town of White Bear.




