## ORDINANCE NO. 538

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS COMPLETELY SURROUNDED BY LAND WITHIN THE MUNICIPAL LIMITS.

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, said land is completely surrounded by land within the municipal boundaries of the City of White Bear Lake and is deemed to be urban in character, and

WHEREAS, the City Council feels that such annexation will be to the best interest of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, the Council of the City of White Bear Lake, Minnesota, does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Beginning at the Northeast corner of Lot 090-41, Govt. Lot 2; thence Westerly along said lot to a point 621 feet plus; thence Southerly along the West 1/2 of the Southeast 1/4 of the Northwest 1/4 of Section 15, Township 30 North, Range 22 West for a distance of 408 feet; thence westerly along the South line of Northwest 1/4 of said Section 15 a distance of 150 feet, more or less, to the centerline of Birch Lake Boulevard North; thence Southerly along the centerline of Birch Lake Boulevard North to the West line of Lot 150-41. Govt. Lot 2, of said Section 15; thence Northerly along said lot line of said Section 15 for a distance of 540 feet. more or less, to the South line of Lot 100-41; thence Easterly along the South line of 100-41, Govt. Lot 2, of said Section 15 for a distance of 341.98 feet; thence Northerly along the West rightof-way line of Otter Lake Road for a distance of 280 feet to the point of beginning and there terminating.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Muricipal Commission, Ramsey County Auditor, Secretary of State of State of Minnesota and Clerk of Town of White Bear.
